

Option to use existing double headers to play three matches




National team matches to be re-scheduled

• For example: Qualifiers 3 & 4 (June 2021) to be moved to two other double headers (e.g. March & October 2021)

Terms of reference



Overall objective: Assess the impact of the current disruptions on the legal/financial framework of clubs and draw up consensual proposals to minimize the negative impact and allow completion of the season

Contractual relationships between clubs and players

Transfer and competition registration deadlines

Club Licensing and Financial Fair Play deadlines and requirements Financial assistance potentially required to support clubs and players

Group split into 2 sub-working groups



Legal framework sub-working group (player contractual matters, competition registration deadlines and transfer matters)



Financial sub-working group (club licensing & financial fair play and broader financial impact of COVID-19 pandemic)

Club Licensing and Financial Fair Play



- CL&FFP should not be suspended
- Overdue payables deadline already extended to 30 April 2020, and no further changes suggested for the time being
- Proposal to extend deadline for submission of licensing decisions for season 2020/21 to 30 June 2020, subject to further postponement of the admission process
- Proposal to suspend for next season provisions related to preparation of future financial information and of the "going concern" principles.
 Alternative measures being sought
- Initial discussions have begun on application of break-even requirement to be continued

Registration of players for UEFA competitions



- The postponement or suspension of competitions across Europe may have as a consequence that the current season may be completed after the original end date of the season
- The original start date of the 2020/21 UEFA club competitions season may also be impacted
- As a result, it may be necessary to postpone a number of deadlines set out in various UEFA competition regulations (e.g. admission process to UEFA club competitions currently set to 1st June)
- Sub-working group has compiled an overview of all such deadlines with a view to bringing them for decision to the ExCo

FIFA Transfer System Task Force



- FIFA Transfer System Task Force is assessing a number of player contractual and transfer related matters that will have to be adapted in order to mitigate impacts of the COVID-19 crisis
- Most challenging issues identified by FIFA (memo circulated earlier this month):
 - What to do with employment contracts (and loan agreements) which will expire on 30 June and with new contracts that will commence on 1st July?
 - What happens to existing contracts (esp. payment obligations) that cannot be performed?
 - How to adapt registration periods and transfer windows to the new set of circumstances?

Proposed approach at European level for player contractual matters and transfer periods



- The next meeting of the (full) WG is scheduled to take place on 3 April
- The main objective is now to narrow down issues and seek agreement on broad principles to form a joint European position (i.e. shared by UEFA, ECA, EL and FIFPRO Europe)
- A collective response makes a lot of sense given the challenging set of circumstances that the whole football family is facing and the need to adapt to a new reality
- This joint position could take the form of a recommendation or a resolution to be addressed to our respective members (i.e. national associations, ECA member clubs, EL member leagues, FIFPRO Europe player associations) and to FIFA (i.e. DRC)



COMPETITION STATUS



- Objective: streamlined completion of qualifying competition
 - April international window to be rescheduled in October
 - June international window (if postponed) to be re-scheduled in November
 - WEURO Play-offs to be re-scheduled in April

 - 23 July- 8 August


WEURO Final tournament dates

Recommended period Summer 2022



Objective:

"To find those dates that are best for the development of women's football and therefore allow for a centre stage positioning for its most valuable tournament, the WEURO."



- 2022 from all points of view is the only viable option
- Objective: keeping it in similar period as planned for 2021
- Discussions and analysis ongoing to define exact period

COMPETITION STATUS

- March and possibly June qualification matches postponed
 - Group matches to be rescheduled to November 2020
 - Play-offs to be rescheduled to March 2021



CONSIDERATIONS

- Full final tournament in June 2021 impossible
 - No space between club season and EURO
 - Olympic tournament in summer 2021
 - Media and commercial value jeopardized
- Current age category 1998
- New Under-21 cycle starting in March 2021 (age category 2000)

Final Tournament - Next Steps

Working (in parallel with WEURO) on rescheduling options in June 2022

Age category to be confirmed (extension of 1 year?)

COMPETITION STATUS

- Elite round postponed (March, 32 teams, 8 mini-tournaments)
- Final tournament postponed (Estonia, 16 teams, 21/05-06/06)
- Not a FIFA World Cup Qualifier



CONSIDERATIONS

- Same players start new U19 cycle in Sept 2020
- Elite round / qualifications difficult in summer
- Risk of potential new cancellation of the Elite Round and Final Tournament



PROPOSAL



- Elite Round cancelled
- Final Tournament cancelled

UEFA Women's Under-17 Championship (1/2)





COMPETITION STATUS

- Elite Round postponed (March, 28 teams, 7 mini-tournaments)
- Final Tournament postponed (Sweden, 8 teams, 09/05-22/05)
- FIFA World Cup Qualifier (3 teams qualify for FIFA U-17 WWC in India in November 2020)



CONSIDERATIONS

- FIFA U-17 WWC draw on 2 September 2020
- Impossible to keep same format
- Simplified format needed to qualify teams to WWC

UEFA Women's Under-17 Championship (2/2)





OPTIONS

- 1
 - **OPTION 1: Single-leg knock-out matches**
 - 29-team knockout qualification (3 rounds single leg) in July or August
 - Final 4 in August
- 2

OPTION 2: MTs and Final 8

- 7 reduced MTs (SF and final only) in July or August
- Final 8 with QF, SF and Final in August
- 3

OPTION 3: Coefficient-based qualification

- 3 teams with best coefficients qualified for the FIFA U-17 WWC
- Elite Round and Final Tournament cancelled
- 4

OPTION 4: Cancellation

(If FIFA U-17 WWC cancelled) Elite Round and Final Tournament cancelled

UEFA Under-19 Championship





COMPETITION STATUS

- Elite Round postponed (March, 28 teams, 7 mini-tournaments)
- Final Tournament scheduled in Northern Ireland (8 teams, 19/07-01/08)
- FIFA World Cup Qualifier (5 teams qualify for FIFA U-20 WC in 2021 in Indonesia)



CONSIDERATIONS

- Need to keep qualification to FIFA U-20 WC
- Elite Round impossible in June, Final Tournament to be postponed



PROPOSAL



- Elite Round in September
- Final phase:
 - Group Phase (2 mini-tournaments with 4 teams each) in Oct or Nov
 - Final 4 & FIFA play-off in Nov or Mar

COMPETITION STATUS

- Elite round postponed (March, 28 teams, 7 mini-tournaments)
- Final tournament scheduled in Georgia (8 teams, 21/7-02/08)
- Not a FIFA World Cup Qualifier



CONSIDERATIONS

- Elite round / qualifications difficult in summer
- Risk of potential new cancellation of the ER and FT

- Elite round cancelled
- Final tournament cancelled
