# COMMERCIAL LEGAL COUNSEL

Reporting to: General Counsel

### MISSION

You will be responsible for managing the commercial legal activities of the ECA legal department, which forms part of the wider Stakeholder Affairs and Legal division. Your mission will be to elevate ECA's capabilities in relation to a wide range of commercial legal matters, both internally as well as externally in representation of its Member Clubs.

You will already have a detailed understanding of the changing global sports landscape (sporting and business aspects) and demonstrable insight into the operational and commercial value drivers of media and sports rights. You also have an understanding of the key aspects of a wide range of industry-related topics, including governance, (i.e. who decides what), regulatory (e.g. key instruments such as UEFA FFP) and sporting (e.g. match calendar, access to competitions and distribution).

You will be experienced and comfortable in analysing and drafting contracts on commercial topics within sports, for example and including intellectual property rights, broadcasting and sponsorship agreements, sports betting, data and agency agreements of various kinds.

You must be a team player and thrive on a collaborative approach to work. You will be a well presented, exceptionally organised individual with first class written and verbal communication skills. You will be a great listener and a strategic thinker, politically aware, comfortable with working directly with senior people in the football industry. Your colleagues and counterparties will see you as a credible, reliable and trustworthy individual.

# ABOUT ECA

- ECA is the sole, independent body directly representing football clubs at European level
- ECA represents the interests of 246 professional football clubs from across Europe, clubs that regularly compete in UEFA Club Competitions

### MAIN RESPONSIBILITIES

Working closely with the General Counsel, this position will have key responsibility for three main areas of commercial activity: (a) guaranteeing that all commercial transactions to which ECA is directly a party adequately protect the organisation's interests and comply with all applicable laws and regulations; (b) ensuring that the rights and interests of ECA Member Clubs are protected in the context of the establishment and exploitation of commercial programmes by international competition organisers (e.g. club competitions organized by UEFA and/or FIFA); and (c) assist ECA Member Clubs in commercial legal matters that may be relevant in the context of their operational activities.

The role will involve:

- Drafting & negotiating various types of commercial contracts with suppliers
- Examine the legal issues related to new products and services
- Providing legal advice (to ECA, but also to ECA Member clubs) in connection with various commercial agreements, including media rights agreements, sponsorship agreements and image rights agreements
- Providing legal advice in connection with regulatory and compliance matters involving commercial components
- Developing institutional positions and policies on the protection of intellectual property rights, notably around broadcasting piracy matters
