Benefits Programme. In 2023,
we renewed our MoU (Memoranda
of Understanding) with both FIFA

across the European football
landscape.

Through meaningful collaboration and development, we foster unity between clubs and with other stakeholders from across the continent. • RESEARCH PROJECTS

MEDICAL & PERFORMANCE

What is it?

ECA is financing innovative research initiatives focused on enhancing player health, well-being and performance in men's and women's football. These projects are designed to help clubs optimise their medical and performance departments to achieve their objectives.

 In men's football, three key research projects have been launched: monitoring real-time cardiac rhythms during games to prevent sudden cardiac arrest, exploring strategies for mental health prevention and care in professional football, and defining the ideal organisational structures for medical and performance departments in professional clubs. In women's football, two
groundbreaking research projects
have been conducted. The first
focused on designing football
boots tailored specifically for
female athletes, while the second
examined the understanding
among players and staff regarding
the menstrual cycle and its
impact on physical performance.
Both initiatives aim to improve
player well-being and optimise
performance in women's football.

What are the benefits?

Access to innovative research projects focused on tackling critical medical and performance challenges in football, enhancing player health, injury prevention and recovery strategies.



YOUTH PLAYERS' DEVELOPMENT

What is it?

We provide clubs with innovative research and studies focused on the evolution and development of youth football. These reports explore various key areas, including the role of football academies, player development pathways, and the impact of coaching and sports science on young athletes. The aim is to improve player performance, foster talent and enhance the overall structure of youth football systems.

3 Strategic Finance & Intelligence

CLUB BENEFITS PROGRAMMES - FIFA & UEFA

What is it?

As part of our MoUs with FIFA and UEFA, ECA has co-created a programme enabling clubs that have released players for certain national team competitions to be compensated.

This programme recognises the contribution football clubs make to the success of the main national team tournaments and ensures that you are compensated for releasing any players to a tournament.

How does it work and how much compensation is available?

There are two different programmes in place.

- With FIFA, a total pool of \$355
 million for each edition of the
 2026 and 2030 FIFA World Cup
 tournaments is available. This
 pool will cover both qualification
 matches and the final tournament.
- Our agreement with UEFA covers the European Championships final tournament as well as any

UEFA European Championship qualification games and UEFA Nations League. For UEFA EURO 2024 and the 2020/21 and 2022/23 UEFA Nations League editions, a total amount of €240 million will be split between the qualification phase and UEFA Nations League games (€100 million) and the final tournament (€140 million).

UEFA CLUB COMPETITIONS (UCC) REVENUE ESTIMATION

ECA FINANCIAL JISTAINABILITY

What is it?

With the 2024-2027 men's cycle, European club competitions have seen notable adjustments both in the competition format and in the overall revenue distribution model.

The changes include an expanded number of participating teams and increased available funds, with a substantial boost in solidarity allocations. Furthermore, a new distribution pillar system has been implemented, providing a simpler and more consistent approach across all three men's competitions, with a stronger emphasis on rewarding sporting performance.

What are the benefits?

Our team of financial experts is here to help your team estimate potential earnings from UCC revenues across various scenarios. As an ECA Member Club, you can rely on us to provide accurate revenue estimates from the UCC framework, including:

- Solidarity payments for non-participating teams
- Earnings from qualifying rounds
- Revenues for participating teams

ECA provided this service to over 90 clubs during the 2024/2025 season and will soon be providing a similar service for the women's club competitions.

Key developments

Members expressed the need for improved methods to run updated and detailed UCC financial simulations based on various scenarios. This will be possible through a digital UCC Revenue Distribution Tool which is currently being developed. The tool is planned to be deployed by the end of the 2024/25 season.

UEFA CLUB LICENSING & FINANCIAL SUSTAINABILITY REGULATIONS

Our dedicated team is here to support ECA Member Clubs in comprehensively understanding the ever-evolving UEFA Club Licensing & Financial Sustainability Regulations. These regulations are crucial for maintaining financial sustainability and ensuring fairness within European club competitions.

ECA's support focuses notably on estimating clubs' compliance with the Squad Cost Rule Ratio by projecting a club's income statement for the following seasons and estimating compliance with the Squad Cost Ratio (SOR) under different scenarios.

We also provide specific advice and clarifications on these regulations from a club perspective.

EUROPEAN CLUB FOOTBALL BENCHMARKING - FINANCIAL & STRATEGIC SNAPSHOT

What is it?

A strategic presentation that aggregates the financials of first division clubs within a specific country, highlighting their strengths, opportunities and challenges when benchmarking with direct competitors at European level.

How does it work?

We collect and aggregate the financial data of first division clubs from all countries affiliated with UEFA. Once aggregated, we benchmark the performance of the country against its most comparable country competitors – those countries that exhibit similar characteristics and behaviour patterns. Our analysis includes in-depth reviews of all financial and strategic aspects based on available information with a focus on any specific and relevant KPIs such as revenues, sporting results and financing models.

What are the benefits?

Clubs gain valuable insights into how their respective league performs compared to other similar European competitors by highlighting their strengths and weaknesses. Therefore, this provides a clear understanding of how clubs within the country can collaborate to enhance their competitiveness against clubs from other countries.

CLUB BENCHMARKING

What is it?

Similarly to the market snapshot, we also support clubs in better understanding their individual position in a European context and how to capitalise on its strengths to further develop by benchmarking them towards their European peers.

How does it work?

We collect the financial data of European football clubs from different countries affiliated with UEFA. Once aggregated, we benchmark the performance of the club against competitors from other countries.

Our analysis includes an in-depth review of all aspects included in the financial statements (Profit, Loss and Balance Sheet), with a focus on the following areas:

- Revenues: matchday, broadcasting media rights, sponsorship & commercial, UEFA and other income.
- Social Media

- Operating expenses: personnel expenses and OPEX
- Transfer market balance
- EBITDA
- Financial costs
- Net equity
- Gross Debt

Additionally, we can provide specific analysis on the impact of implementing projects within a club (e.g. revenue increase from expanding a football stadium).

What are the benefits?

Clubs gain valuable insights into their performance compared to similar European clubs from different leagues. This analysis highlights their strengths and weaknesses, offering a clear understanding of the most important aspects to focus on for future development. It can be used to support clubs in various stakeholder relations.

ECA SUSTAINABILITY STRATEGY & FRAMEWORK

Interviews with key representatives from the European football landscape and a survey of our member clubs have helped us define the topics we need to prioritise. We also frequently meet with UEFA's Social and Environmental Sustainability team to develop joint training initiatives for member clubs.

The strategy serves as a dynamic. evolving framework that empowers both ECA and our member clubs to implement measurable actions aimed at improving all aspects of sustainability. Our goal is to simplify what can often feel like a complex set of challenges, making them more approachable and manageable for all clubs. By adopting a comprehensive sustainability strategy, clubs can not only mitigate risks associated with inaction – such as regulatory issues or damage to reputation but also seize exciting new opportunities within a rapidly changing landscape.


